## **REUNION 335 IN LEXINGTON, KY IS ONE FOR THE BOOKS!**

For those of you who missed our most recent national reunion in Lexington, KY, I am so very sorry. We had such a great time! After over two years of COVID restrictions, it seemed that everyone arrived with a smile on their face. We had a great reception Thursday night, first-rate tours on Friday and Saturday mornings, and interesting speakers on those afternoons. We then topped it off Saturday night with a wonderful banquet, basket raffle and silent auction, and a world class magic show by one of our Harlan cousins! The Sunday worship service set a new standard for all future services, and I was so glad I could attend. And that does not include the time spent with immediate family and new cousins.

Registration began on Thursday with the hospitality room hopping. Folks brought baskets

representing their states, and several other items were available for silent auction, including a "green book" (Alpheus Harlan's book), and a basket with a one-of-a-kind Harlan decanter and glasses (with bourbon to go with it, of course). Information about the Harlan-Lincoln House in Mt. Pleasant, Iowa (we have made annual donations for many years to support them) was on display, along with scrapbooks from previous Harlan trips abroad. Tony and Debby Harlan had pre-ordered T-shirts, hats, etc. for the Harlan Store, and quickly sold most of the extra items they brought. Mike Harlan had a table in the Hospitality Room with detailed research on the Harlan families from Kentucky via a looping PowerPoint.

Thursday night's reception was well attended and included two special guests. Ed Smith,

with Kentucky Chautauqua, played the role of Supreme Court Justice John Marshall Harlan. His brief speech represented the life and times of the Justice. Afterwards, he made rounds and briefly visited with those who gathered. C.J. King, in her role as Mary Harlan Lincoln, appeared in costume and persona. The two personalities worked the room and provided many photo opportunities. Both did a fantastic job! Ed Smith admitted to being a little nervous to make his appearance with so many Harlan descendants. He also admitted he had a blast doing it! The food and drinks were great, but the company was the best part. It was a great way to start the reunion.



On Friday morning the buses loaded and headed in several different directions, all passing through Kentucky's beautiful horse country. A few dozen Harlan's toured the bourbon distillery of Buffalo Trace in Frankfort that included a drivethrough tour of the

Keeneland Racetrack. A second tour got a behindthe-scenes look at the Keeneland Racetrack and the Old Friends Thoroughbred Retirement Farm. A third tour went to Keeneland Racetrack, followed by an intimate tour at the Claiborne Farm horse farm.

The afternoon included breakout sessions at our headquarters hotel, the Downtown Hilton. Unfortunately, the DNA talk was cancelled due to a death in the speaker's family. Many were looking forward to the talk, so we will be sure to cover that topic at the next reunion. Robert Worden of Paducah, KY spoke on the life of Silas Harlan, a frontiersman with Daniel Boone who died at the Revolutionary War Battle of Blue Licks. Harlan County and the town of Harlan, KY were both named for Silas. C.J. King made a second appearance as Mary Harlan Lincoln, and was present to answer questions at the tours of the Mary Todd Lincoln House. These tours and presentations were well-attended and thoroughly enjoyed. The official business meeting of the Harlan Family in America was held late Friday afternoon, with a good number of attendees, and the new officers of the

Board of Directors were elected, and three new board members introduced.

Saturday started again with bus outings, this time for a tour of Three Boys Farm Distillery and that gorgeous countryside. This was a more detailed tour of a smaller and newer distillery, but the feedback was terrific. Another tour explored Keeneland Racetrack, Claiborne Farm, and the surrounding area. There was also a small group tour to Keeneland Racetrack and Magdalena Farm. The Saturday afternoon sessions were also well attended. Peter Canellos, author of John Marshall Harlan -The Great Dissenter, delivered two sessions that afternoon. His bookseller left with only a handful of unsold books. Fred Harlan and Steve Harrison (both Harlan cousins) led breakout sessions on genealogy. Susan Lindsey presented a Zoom session from Portugal, on her book Liberty Brought Us Here. This book included one of our Kentucky Harlan relatives who freed his slaves to return to Africa. Robert Worden presented a second talk with a focus on the history of quilts, and Kentucky Quilts (probably his true passion).

Saturday evening culminated with a cocktail hour (as the Board frantically moved the baskets and silent auction items upstairs and prepared for the rest of the evening), followed by the banquet. King. The service ended as we all joined in singing *A Family of Friends*, music written by Rebecca Gaskill in memory of her mother Mary J. Harlan Gaskill for Celebration 300 in 1987.

I would be remiss to not thank the entire Board of the Harlan Family in America. Something this large is not successful without the work of many. This was my first reunion as chair, and I felt very inexperienced. Peggy Harlan Hewitt was the co-chair, a dear friend and cousin and an integral part of the entire process (the planning takes 4 years and goes a LOT more smoothly without a pandemic). Mary Harlan Murphy and Fred Harlan handled the registration like they had done it a dozen times. Robert Harlan (Pennsylvania Bob), as treasurer, was the voice of reason and a great sounding board. ## GENEALOGY CORNER LITTLE KNOWN COUNTY RECORD SOURCES

The average American ancestor resided in several places during his lifetime. Each place contained several jurisdictions including federal, state, county and local sources. Most of our ancestors who lived in the early federal period didn't litigate in federal district court but federal circuit court. But the federal circuit court ceased in 1912. For some counties there may be 2 courthouses so be sure to check all in a given county. Ancestors also created records in neighboring counties. It might have been closer to go to the next county than down the river or over the mountain or through a dense forest. The dates you are searching may determine which courthouse you use also. This might mean vou have to search several counties even though your ancestor lived on the same land during the time period. Some clerks will tell you the records were destroyed but that isn't necessarily so.

Some of the "little known" resources include: (don't laugh at some of these!) Bureau of Pensions Survey, Cherokee Land Allotment Certificate, Bankruptcy Records, Donkey Licenses, Invalid Pensioners payment records, Military Service Certificates, Mining Claims, False Teeth Guarantees, Portage Books,

Presidential Civil War Pardons, Manumission Certificates, Newspaper or Magazine Subscriptions, Old Age Assistance Tax Payments, Steamboat Passenger Lists, and Abstract of Licenses Granted to Trade with Indians west of the Mississippi.

These are just some of the more unusual places to look, but give the courthouses a chance first. I found an ancestor had applied for a marriage certificate in the county south of where he lived. *Cynthia Rhoades*

## HOW MUCH DOES IT COST TO PUT ON A NATIONAL FAMILY REUNION?

What is the cost of a Harlan Family in America reunion? That was my question five years ago, when I took on the job of being co-chairman for the Lexington reunion. The goal was to minimize the costs to the participants, while still offering fun and interesting activities, which included the reception and the banquet held at a large downtown hotel.

This year 265 people registered for the reunion. Over two days and six possible tour events, 215 seats filled. We fed and entertained at least 210 people at the banquet.

The total paid to the Hilton Lexington was just over \$17,000. This included all the food and lemonade/iced tea for the Thursday night reception, the coffee bar on Friday, and the bartenders, wait staff, food-- everything for the banquet on Saturday evening. It also includes all the audio-visual setup, which totaled over \$3,000, and a 25% tip/administration fee, excluding the audio/visual fee.

This year's reunion focused on great presenters. The tab for the speakers and presenters was approximately \$1,300. A portion of presenters'

hotel accommodations and travel expenses were covered.

The tours ran about \$10,000, which included fees paid to the Mary Todd Lincoln House, horse farms, bus companies, and distilleries. Our organization paid the tour costs to the Mary Todd Lincoln House and supplemented some costs of the other tours. One last minute change in a tour unexpectedly forced us to assume half that charge.

Expenses for the two mailings prior to the reunion, printing for reunion folders and packets, etc., plus supplies totaled around \$4,800. That does include enough name tag lanyards to last a while.

Our total registration income was just over \$23,000. We profited about \$2,400 on the silent auction and raffle sales. The Harlan Store netted around \$760.

Many family members donated money to offset the costs of the reunion. Still, we managed to contain the costs quite nicely, which left us with a surplus of money. The Board has already discussed this, and this money will be set aside to give us a head start toward expenses for the next reunion.
